## 7 Major Factors That Determine Who We Are.

#### 1. Genes

Normally a woman's chromosomes are XX. A Man's chromosomes are XY. Mom and Dad each contribute one chromosome to baby. Mom supplies a X. Normally, if dad contributes an X chromosome, the baby is supposed to be female. If he contributes a Y chromosome the baby is supposed to be male. But if a toxin interferes with this process, the genes can be multitudes of mutated variations, such as XXY or XXYX or ???. Also if the toxins interfere with the correct instructions that the genes send to the body, to make a girl or boy, the amounts of testosterone or estrogen required for one or the other may be interrupted. A genetic boy may get too much estrogen and be feminized to the point that "his" body develops into a woman and he may be able to bear children (possibly need some medical help). A genetic "girl" may develop a man's body and she may be able to father children. She may not even know she is a genetic woman, or she may be very acutely aware of it if her identity is still female.. This can happen on a spectrum of feminization or masculinization, some more affected than others and in multitudes of variations.

Today's science is aware of this phenomenon. It is part of a condition called "endocrine disruption", which includes disruption of many organs/glands, including the brain, pineal, hypothalamus, pituitary, thyroid, parathyroid, thymus, adrenals, pancreas, ovaries, testes, and other secondary organs that actually do secrete hormones under certain circumstances. However, most informed scientists do not discuss the gender alteration side of endocrine disruption due to political and societal pressures. They may unspecifically mention that endocrine disruption may in some cases cause developmental or behavioral changes, or confusion or reversals. A few scientists have spoken up and of course were challenged and attacked by chemical/vaccine/drug corporations. So a well known phenomenon in science, worldwide, is not well understood by the public. Most gender altered people do not understand that chemicals can create these mutations, reversals, deformities and injuries. Since some of them have been gene tested and know they have unusual chromosome combinations, they assume they are a product of evolution and that there are "52 genders", etc. They conclude that Christians are mistaken when they say God created male (XY) and female (XX), because they can prove their genes don't match this design. They do not realize this is a chemical or vaccine induced mutation of God's original designs. Often when first presented with this information it is hard for them to accept that they suffer a mutation or injury/deformity. (I'm not deformed/injured, etc.) But on the flip side, they do not want more babies born with these issues. They understand the misery.

**Note:** Vaccines which contain the DNA of babies who were aborted and dissected alive without pain meds, are being fingered for a process called insertional mutagenesis, in which the fragmented dna of these little boys and girls is inserts itself into the nuclei of cells of the vaccinated children. This is known to cause cancers, particularly lymphomas and leukemia, autoimmune disease, and gender identity disorder. Essentially it is cannibalism, worse, it is injected not ingested. Measles, Mumps,

Rubella, Varicella (chickenpox), Meningitis, Hep A and B, Pentacell, and Shingles vaccines, possibly more, all have aborted fetal cells in them. A well known and respected Christian autism doctor has found the "third dna" in some of his autistic patients and it has shown up in stem cell research.

Insertional mutagenesis can also occur when fraternal male/female twins are conceived and one dies early in the pregnancy. Mom may never know she conceived twins. The living twin may absorb the dna of the one who died and therefore become a "chimera", ie, with both male and female dna. Different organs may have different dna and this can create gender confusion and be a problem for crime investigation and organ transplantation. Endocrine disruption is sometimes "humanly" responsible for the conception of twins so this type of chimera may be a product of chemical injury.

### 2. Anatomy

Some babies are born with visible anatomy that is not identifiable male or female. They may not even be able to urinate until transitional surgery is performed on them, usually in babyhood. Parents and doctors try hard to make the right choice, but surgically it is easier to make a girl than a boy. This may not always work out for the child after puberty hits if the wrong gender is chosen.

Some children are born with male parts on the outside and female parts on the inside. Or vice versa. Often this is unknown until the child has reason to undergo abdominal surgery and opposite parts are discovered or a "boy" starts menstruating or a "girl" never gets her periods.

There is a community in the Dominican Republic that 1 in 90 prevalence of a rare genetic disorder in which the lack of an enzyme causes an anatomical girl to develop visible male parts at puberty. "She" literally changes into an anatomical boy. However, child often identifies male from birth.

Many chemicals are endocrine disruptors and can upset anatomical development and/or change organ FUNCTION all over the body, including an organ called the brain, and glands in the brain (pituitary, pineal, hypothalamus). The variations and combinations of the mix of possible injuries/alterations/deformities is nearly endless.

#### 3. Hormones

Hormones are a FUNCTION of glands and other tissues that excrete them.

Our hormones determine how our bodies, organs, glands work, by signaling. Our cells have many different tiny "receptors" or doorways that let substances, etc., into the cell. Those doorways are shaped to fit specific nutrients or hormones, like a puzzle piece. If a cell has a doorway to let testosterone inside then antennaes on both the testosterone hormone and the cell may sense each other and draw them it to the doorway. The testosterone "tells" the cell to make something male. Estrogen tells cells with estrogen receptors to make something female.

Testosterone and estrogen are the major gender related hormones. Endocrine disrupting chemicals can interrupt and hijack the instructions that regulate how much of each hormone is produced. This in turn affects how much hormone is available to make male or female parts. See pages 8,9,10.

### 4. Attraction.

Endocrine disruption by a toxin before or after birth (or other factors) may change sexual attraction. It is also considered by professionals that abuse may trigger same sex attractions. It is relevant however to consider the chicken/egg phenomemon as a child's same-sex attraction or gender altered behavior may incite abuse by others.

It is vital to differentiate between Same Sex Attraction (SSA), and the terms "gay, lesbian, or bisexual" which generally communicates BEHAVIOR to most people. A same-sex attracted person may never actually act on that attraction, and may live a totally scriptural, celibate sexual lifestyle.

"Asexual" is a condition in which the person does not experience sexual attractions.

Most Christians recognize that we live in a society been given over to a willful, reprobate mind. But many Christians would not view "same-sex attraction" which is genuinely triggered by a toxic injury to be more uniquely sinful above common heterosexual lust in one's heart. Matthew 5:28 But I tell you that anyone who looks at a woman lustfully has already committed adultery with her in his heart.

Transgender people are in a conundrum. Since they have both male and female characteristics, what is heterosexual vs same sex attraction for them??.

It is vital to understand that cross dressers, drag queens, etc., are NOT gender altered. They are usually fully male or female, and satisfied to be so, but choose to dress the opposite gender for entertainment, usually in a distant neighborhood. However, if they run into trouble or are abused due to their "parade", they are quickly back home in their suits and ties. Scripture is plain that cross dressing/transvestitism, is not ok. Deuteronomy 22:5.

I have been told by a medical practitioner of a case in which treatment of a seemingly unrelated health condition also healed the person's same sex attraction. The treatment consisted of detox measures among others. Also a heads up practitioner who practices iridology has related to me that every single same sex attracted person he has examined has toxicity in the same spot of the iris of the eye, which corresponds to a particular place in the brain. Once more, toxicity is the focus.

## 5. Identity

Identity denotes who each person innately <u>knows</u> they are, male or female. Identity is not sexual attraction. Identity can only be confirmed by the person themselves, and overrides every other dissonant factor. This can be the most difficult piece of gender disruption for others to understand, particularly if identity is incongruent with anatomy.

Christians often remark that if transgender people understood who they are in Christ, they would not be troubled with gender identity disorder. However, this is an irrelevant, false godly "solution" and does not apply any more to transgenders than anyone else.. Transgender people (excepting gender fluid) know very well which gender they are! They are not confused in their identity, and know God accepts them as made in His image, but hypocritical "cis" (unaltered) Christians do not. Ooops!

**Gender fluid** is a very difficult condition in which a person's gender identity is unstable, sometimes by the day. Professionals claim that some gender altered children appear to outgrow this condition, but others definitely do not. Insertional mutagenesis from human aborted male and/or female cells in vaccines may contribute to this puzzle

#### 6. Role.

Regardless of other aspects, what general role in life does an individual naturally play? Are they the nurturer or breadwinner, do they naturally go for carpentry and plumbing or sewing and cooking? Does the child prefer trucks and cars or dolls and ponytails? This may tie into identity or it may not, depending on the individual. Scripture mentions bringing up a child according to the tenor of the child's way. Could this verse perhaps give us freedom and flexibility to assess, accept and develop a child's or adult's natural gifts and instincts when clear gender confusion is present?, Vs attempting to force a child into a mistaken gender role that is overwhelmingly unnatural to that child.

A confusing aspect of role in the case of particularly girls who are misidentified as boys is their attempt to perform "hypermachoism". In an effort for these girls to live in their misassigned male gender they may attempt activities and careers that are male dominated, such a policepersons, fire fighters, etc., play sports (and get hurt), learn to work on cars, etc. Misidentified girls are more likely to try to perform in unnatural male roles than boys, partly because they wish to please society and fit in, and also because boys who are misidentified as girls are more accepted as "tomboys". (A butch "girl" is better socially tolerated than a feminized "boy".)

However, these girls misidentified as boys may eventually give up, admit they are women, and opt to complete/transition physically to match their actual identity. This can be very confusing to family and friends who saw previous hypermacho male behavior.

42.5 % of gender altered individuals commit suicide. 33% successfully. They are serious!

## 7. Spiritual.

A vital principle for all, but particularly gender altered people is to be very clear, who they are in Christ. Spiritually we are all one in Christ and In heaven there will be no male or female. This can be a true comfort to those who are socially gender altered in some way. However, knowing who we are in Christ does not negate the serious problems a transgender person faces, nor our responsibilities as a church.. Actually transgender persons already know they are perfect in Christ, made in His image. But many

Christians have missed that point and often feel free to discard them more than any other category of society. It is beautiful to see that "eunuchs" are spoken of in Scripture as a possessing a birth defect from the womb, having sustained an injury, and/or as having chosen to remain single for the sake of the Kingdom of Heaven. They are precious in God's sight, and are given a beautiful place in the temple worship in Scripture. Isaiah 56:1-5.

**Matthew 19:12** For there are eunuchs who were born that way from their mother's womb; and there are eunuchs who were made eunuchs by men; and there are also eunuchs who made themselves eunuchs for the sake of the kingdom of heaven.

1. Isaiah 56:1-5 ¹This is what the LORD says: "Maintain justice and do what is right, for my salvation is close at hand and my righteousness will soon be revealed. ²Blessed is the one who does this- the person who holds it fast, who keeps the Sabbath without desecrating it, and keeps their hands from doing any evil." ³Let no foreigner who is bound to the LORD say, "The LORD will surely exclude me from his people." And let no eunuch complain, "I am only a dry tree." ⁴For this is what the LORD says: "To the eunuchs who keep my Sabbaths, who choose what pleases me and hold fast to my covenant- ⁵to them I will give within my temple and its walls a memorial and a name better than sons and daughters; I will give them an everlasting name that will endure forever.

### Should a gender related birth defect be treated or left untouched?

Regarding birth defects, usually caused by endocrine disrupting chemicals, mercury or other phenomenon such as chimerism, we remember that Jesus acknowledged and healed folks' infirmities including birth defects (blind, lame, a withered hand). It was often ok with him to fix their defects. Scripture also allows for medical treatment of illness and injury (the woman with an issue of blood) and speaks lovingly of Luke the beloved Physician and Jesus as the Great Physician.

No one argues that a birth defect such as a cleft palate shouldn't be fixed.

God does not always heal, as in Paul's thorn in the flesh, so we have no cause to place such a burden of enforced healing?? on others ("If you would be spiritual enough God would take this away").

Transgender people understand that treatments do not completely take away their dysphoria, but in many cases they do help a great deal" Treatment can be a "way of escape, that they may be able to bear it."

Clearly the morals set out in Scripture do not change. Some injuries may necessitate a celibate lifestyle. Christian friends can help support, love, accept and value that individual. We can help them lead single lives of significance and honor in service to the Lord in the gender which matches the tenor of their way AND their own assessment of themselves before God.
